New Bill Affects 2016-2017

Bill A 1872 - Imposes \$0.25 surcharge on alcoholic beverages to be dedicated to Alcohol Education, Rehabilitation and Enforcement Fund.

This bill provides for a \$0.25 fee to be included in the price of each alcoholic beverage sold in certain municipalities for the purpose of funding alcohol education, rehabilitation and enforcement.

Under the bill, the holder of a retail liquor license authorizing the sale of alcoholic beverages in a restaurant or bar which is located in a municipality with 200 or more of these licenses currently active or inactive is required to charge a fee of \$0.25 to be included in the price of each alcoholic beverage sold on the licensed premises. These fees are to be collected by the Director of the Division of Alcoholic Beverage Control and deposited in the Alcohol Education, Rehabilitation and Enforcement Fund (AEREF).

Under this bill, the AEREF also would receive the proceeds from the \$0.25 per drink fee imposed by the bill on alcoholic beverages sold in restaurants and bars in municipalities with a large number of retail liquor licenses.

Bill A 1755 - The "Green Building Tax Credit Act."

This bill, entitled the "Green Building Tax Credit Act," provides tax credits toward the corporation business tax, gross income tax, and certain other specified taxes for developers and owners who design and construct buildings that meet certain "green building" criteria.

The bill provides that a building would qualify for the tax credits if it meets the green building standards set forth in section 7 of the bill to be adopted by the Department of Community Affairs (DCA) in consultation with the Department of Environmental Protection (DEP), or if it meets the criteria required for Certified, Silver, Gold, or Platinum status under the LEED Green Building Rating System or LEED Residential Green Building Rating System.

The tax credits provided by the bill would be available for seven years. The total of all credits which could be allocated in the

first fiscal year after enactment would be no more than \$20 million. In each of the subsequent six fiscal years, up to \$50 million of credit allocations may be authorized per year, and any unused allocable amounts may roll over to subsequent fiscal years. An eligible taxpayer may apply no more than 20% of their total tax credit in any tax year.

Bill A 183 - Requires certain entities to be equipped with generators and allows those entities to qualify for NJEDA loans for cost of generators.

This bill requires retail motor fuel dealers, motor fuel wholesales, motor fuel terminal facilities, motor fuel refineries, nursing homes, assisted living facilities, subacute rehabilitation facilities, and newly constructed grocery stores (collectively, "eligible businesses") to be equipped with and employ a generator in the event of a power outage.

The bill also requires the New Jersey Economic Development Authority ("authority") to offer financial assistance in the form of low-interest loans to eligible businesses for the purchase and installation of a generator. The authority must begin accepting applications no later than 91 days after the enactment of the bill and must begin approving the applications within a reasonable time thereafter.

An eligible business that sustains physi-

cal damage to the business itself, or to the business's generator, during a disaster are exempt from the requirements of the bill. The bill outlines a series of penalties for eligible businesses that fail to use a generator during the course of a power outage.

Bill A 563 - "New Jersey Jobs Protection Act;" requires verification of employment.

This bill, the "New Jersey Jobs Protection Act," requires that all employers use the federal "E-verify" system to check the employment eligibility of each new hire, within ninety days of the date of hire.

The bill establishes a graduated penalty system against any employer who knowingly employs illegal aliens. The penalty for the first offense will be a \$10,000 fine for each illegal alien and three years of monitored probation. During the probationary period the employer is required to file quarterly reports with the county prosecutor. The reports must include, but shall not be limited to, documentation of the E-verify confirmation of each new employee who is hired by the employer at the location where the illegal alien performed work.

The penalty for a second offense will be a \$20,000 fine for each illegal alien and an additional five years of monitored probation. The penalty for a third offense will be a \$30,000 fine for each illegal alien.

Bill A 651 - Permits self-service dispensing of motor fuels.

Self-service at gasoline stations is now permitted in all but two states and has proved to provide customers with efficient, economical and safe service. Nationwide estimates indicate that about 80 percent of all retail gasoline sold in our country is currently being dispensed on a self-service basis.

This bill permits self-service operations in New Jersey and directs the Commissioner of Labor and Workforce Development to promulgate appropriate regulations to govern their operations.
